


Who We Serve

Selkirk Fire Rescue & EMS serves and protects approximately 25,000 people in 194 square miles. Despite our best efforts of prevention, when response is required, it will be effective and purposeful. We will seek innovations and external partnerships to increase efficiencies and maximize resources, and will serve as role models for implementing change in our industry.

Serving our community is a privilege. Whether it is a true emergency or a situation where a citizen has simply exhausted their personal resources, we will exceed the expectations of our community. We recognize that we are accountable to the public we serve and will be good stewards of the finances and resources entrusted to us.

Our fire stations are strategically located throughout our service area, ensuring a quick and immediate response to any situation. Keeping in mind, we service a large rural area, which can result in extended responses. Our service area includes the following cities and unincorporated portions of Bonner County:

Who We Are

Whether it is a medical incident, fire, hazardous material incident, rescue situation, marine incident, or natural disaster, our Firefighters are trained and ready to respond. Selkirk Fire's specialty rescue teams respond to incidents involving hazardous materials, high angle rope rescue, confined space rescue, structural collapse and ice rescue. Our personnel logged approximately **8,128** hours of training in 2018.

Our department staff is comprised of one Chief, one Assistant Chief, one Executive Assistant, 22 Career Firefighters, four Resident Firefighters, and 22 Volunteer Firefighters. The community is served from four full-time staffed stations, and five volunteer stations.

Station 1 (Sandpoint) is our administrative headquarters. The administrative office is open 8:00 a.m. to 5:00 p.m. Monday through Friday. Station 1 also houses Battalion Chief 1103 and Truck Company 1141. Both units operate 24-hours a day, 7 days a week.

Station 2 (Dover) has four Resident Firefighters. The Resident Firefighters and Battalion Chief respond to all emergencies in the Westside Fire District.

Station 3 (Sagle) staffs Engine 1231 with two Firefighters. Cities and un-incorporated areas in 1231's response area includes: Bottle Bay, North end of Cocolalla, Garfield Bay, Sagle, Westmond, and Willow Bay. This is Selkirk Fires largest response area.

Station 4 (Careywood) was remodeled in 2018 and opened on January 1, 2019, which converted two of the pole buildings four vehicle bay into a living space. It has been our long-standing goal to improve response times and coverage in southern Bonner County. Response time is currently 20 to 25 minutes. Staffing at the station is expected to cut our response times roughly in half. Sagle spent approximately \$121,563.00 on the remodel.





Opened on January 1 and is staffed 24/7.

Selkirk Fire, representing Sagle Fire, secured a three year Federal Emergency Management Agency Safer Grant for \$720,351.00 to hire three new Firefighters. Together with the capital remodel improvements the Careywood Station 4 will have 24-hour/7 days a week coverage. The station staffs a Tactical Tender with two Firefighter EMT's most of the time for an additional cost of approximately

\$40,000/year. Station 4's response area includes: South end of Cocolalla and Careywood to the county line. This station works down to one person when another Firefighter in the district is on vacation.

Due to budget constraints, Sagle is not currently able to staff this station constantly with two Firefighters. The station is staffed 24-hours a day, 7 days a week.

Station 5 (Wrenco) is staffed with one 40-hour week Firefighter who is responsible for maintaining the Dover, Wrenco, and Laclede stations and apparatus. During the day, the Firefighter and Battalion Chief respond to all emergencies in the Westside Fire District. With the Resident Firefighters in Dover and the 40-hour week Firefighter, the citizens in Westside Fire District have 24-hour, 7 days a week coverage.

Joint Powers Agreement

It is economically unfeasible for any single government jurisdiction to equip and staff itself with sufficient forces to cope with the maximum situation that may occur. The combining of emergency services among local units of government provides opportunities to improve the level of services provided to the citizens while maintaining a consentient level of funding. Prior to the Selkirk JPA, the emergency service delivery system was fragmented which led to a significant duplication of services and inefficient utilization of resources. The Selkirk Fire JPA system allows for the closest unit response and a regional approach to emergency services delivery.

The principle benefits of a regional system is a more efficient use of funds, increased effectiveness and a depth of resources unmatched in the county. The consolidation of resources, the streamlining of overhead and a partnership in a regional protection system is beneficial for all parties.

The Selkirk Fire Joint Powers Agreement (JPA) has allowed fire departments to increase their capabilities and become more efficient in regards to emergency responses, fire prevention, public education and community outreach. The JPA has been developed that will allow other organizations to join and participate in the consolidation.

The JPA is managed by a Board who is represented by two Sandpoint City Council Members (Bill Aitken and Tom Eddy), two Sagle Fire Board Commissioners (Matt Linscott and Tom Trulock), two Westside Fire Board Commissioners (Will Gadsby and Allo Pucci) and a member from the community (Brett Converse). The Board approves all aspects of the District except finances, which are currently kept separate; however, employees and equipment are intermingled.

What occurred between the City of Sandpoint, Sagle Fire District, and Westside Fire District is a great example of good government at work. Instead of having three separate fire departments operating separately, the community now has a better-equipped emergency services delivery system.


Selkirk Fire JPA shares the cost of salaries and benefits for its administrative staff and includes a Fire Chief, an Assistant Fire Chief, and an Executive Assistant. Each agency is responsible for a total yearly cost of \$101.000.00.

JPA Benefits


City of Sandpoint

Through the JPA, the City is saving \$21,000. In addition to the savings, the City gains an Executive Assistant, Assistant Chief, constant staffing of three which includes the Battalion Chief, four additional 24/7 staffed stations with four Firefighters on duty each day, one 40-hour a week Firefighter, four resident Firefighters, and 22 Volunteer Firefighters.

Selkirk Staffed Apparatus




Sagle Fire District

Through the JPA, the savings is \$86,000. In addition to the savings, Sagle Fire gains an Assistant Chief, Battalion Chief, three additional 24/7 staffed stations with two personnel on duty each day, one 40-hour a week Firefighter, four resident Firefighters, and 22 Volunteer Firefighters.

Selkirk Staffed Apparatus





Westside Fire

For the JPA, \$35,000 was re-allocated in the current budget to personnel costs. Westside Fire gains an additional Chief Officer, Executive Assistant, Battalion Chief, three additional 24/7 staffed stations with six personnel on duty each day, four resident Firefighters, and 22 Volunteer Firefighters.

Idaho Surveying and Rating Bureau

Idaho Surveying and Rating Bureau is an independent rating organization operating with a license from the Idaho Department of Insurance as a "rating making organization" for property insurance.

In 2017, the **City of Dover** and **Laclede** residences insurance rating changed to a **Class 4.** For some, the reduction in insurance cost will save homeowners more than the total amount they pay annually for fire protection. In December 2018, the **City of Sandpoint** improved its rating from a **Class 4 to a Class 3**.

The improved insurance class ratings for both these cities are a direct result from Selkirk Fire's JPA. Due to the close proximity of the Dover and Sandpoint fire stations, two engines and a ladder truck are able to respond simultaneously. Sagle, Sandpoint, and Westside were able to combine all personnel and received a greater amount of points for "company personnel". Re-organizing our training program, emphasis on pre-fire plans and inspections also allowed the agency to capture more points. We are continually gathering data on individual homeowner and business insurance savings.

Budget and Funding

Currently, Selkirk Fire, Rescue and EMS is an operational only entity. Each of the communities finances are kept separate. Below is how each District/Department receives funds to operate.

Sagle Fire District: Levy Rate is **.001727419**. This means for every \$100,000.00 of value of improved property the Sagle Fire District collects \$172.74. Sagle Fire District is one of a very few fire districts in Idaho that only levies on improved property. In 2015, there was 9,272 levy paying parcels. There are 13735 non-levy paying parcels. 2018 -2019 Annual Budget: \$1,416,647.00.

Sandpoint Fire Department: Tax dollars are collected through property taxes. Monies collected are distributed to each of the various City Departments. The Fire Department receives their funding at the discretion of the City Council. 2018 -2019 Annual Budget: \$1,348,755.00

Westside Fire District: Levy Rate is .000712616. This means for every \$100,000.00 of value of all real property (improved and unimproved) the Westside Fire District receives \$71.26. The Westside Fire District currently has a bond for fire station construction that is an additional assessment to the District residents. The bond rate is .000087908. This bond will mature in 2030. 2018 -2019 Annual Budget: \$388,212.00.

Annexation: Sagle received 15 parcel requests consisting of approximately 256 acres. Westside received 13 parcel requests consisting of approximately 578 acres. Total annexation value is approximately 2 million dollars.

Grants

Selkirk Fire actively participated in grant opportunities. In 2018 we received \$798,392.00 in grant revenue.

- ITD Parking Lot Grant: \$34,441 + 10% match for paving parking lot at Sagle Station 3
- TransCanada Wildland Personal Protective Clothing Grant: \$5,000 for Sagle protective clothing



In 2018, a limited term Wildland Firefighter position was created for the period of June 1st through September 30th. Ryan Jackson and Zach Pohl were hired and assigned to operate a Tactical Tender. The primary mission of the program is to accept wildland contacts for regional protection and suppression. In between assignments, the crew worked at the Careywood station responding to all emergencies.

Community Risk Reduction

Selkirk Fire conducted 789 business inspections and pre-fire plans in 2018.

When you drop off your kids at school, go to a movie, eat out at a restaurant, or attend a religious service, do you think about how safe the building is? Selkirk Fire does. In fact, our fire crews inspect hundreds of buildings every year in an effort to ensure your safety. The Fire Prevention Division has the responsibility for enforcing local, state, and federal codes in order to reduce the loss of life and property from preventable fires and other emergencies; this is accomplished through inspection and code enforcement, plan review, public education and fire investigative services.

Throughout the year, Selkirk Fire will inspect your building. Some inspections will be pre-scheduled and some will not. The firefighters who conduct the inspections are on duty and their schedules are fluid and frequently interrupted by other emergency responsibilities.

In general, areas of concerns Firefighters will look for are:

- Fire alarm system is it working with an absence of trouble signals?
- <u>Fire sprinkler system</u> has it been serviced, tagged and tested?
- Exits are the exits, exit corridors, and hallways unobstructed? Are the exit signs illuminated?
- Fire extinguishers have they been serviced and tagged in the last twelve months?
- Kitchen hood system has it been serviced and tagged?
- General cleanliness is there combustible trash building up in the common hallways or exterior grounds?
- Walls and ceilings are there holes in the walls or ceilings that will allow fire to travel in hidden spaces?
- Knox Box is there a Knox Box in place with proper door keys and fire alarm panel keys?

We want to thank you for your participation in our Fire Prevention Program. We believe that by working together, we can keep your business as safe as possible.

Volunteer Program

Our Department staff is comprised of career and volunteer Firefighters. Our Volunteer Firefighters work and train alongside our paid crews to provide a second line of defense. We currently have **22** commissioned Volunteer Firefighters to perform frontline tasks at emergencies and participate in community support programs.

In 2018 Volunteers conducted **1,370** hours of training. Selkirk Fire spent **\$13,235.00** towards Volunteer incentive pay.

Occupational Health and Wellness

Safety and performance are at the heart of Selkirk Fire's core principles. This principle commands that everyone who comes to work goes home from work, and everyone is expected to perform their duties at the highest level without compromising safety. The investment of staff, equipment, and health screening is a reflection of the importance that Selkirk Fire attaches to the responsibility of protectioning our most valuable resource; our personnel.

Purpose

The purpose of the Occupation Health and Wellness is to ensure that all personnel work safely and effectively during their careers and maintain healthy lifestyle choices continuing into their retirement. We educate employees through a variety of channels about lifestyle behaviors and how they influence one's health, self-esteem, and overall job performance throughout a lifetime. For our uniformed personnel, offering wellness services and implementing programs strategically focused on providing the strength and support they need to meet demands and rigors of the job. District wide, we strive to provide a comprehensive array of in-house prevention driven health and wellness services to all personnel, volunteers, and family to improve the quality of life and longevity.

Services include:

Annual Medical Screening

- Lab draws and metabolic testing
- Physical (musculoskeletal), including BMI
- Vision (Snellen) and color (ishihara) testing
- Otoscope
- Vitals
- Spirometry
- UA test

Health, Wellness, and Safety Promotion

- Fitness evaluations
- Allotted fitness time during each shift
- Fitness programs
- Nutrition counseling

Community Programs and Services

Discretionary Fund

The Discretionary Fund is sponsored by Angles Over Sandpoint and the Volunteer Firefighter Association. This fund allows on-scene Firefighters to spend up to \$100 to assist a citizen or family in need. \$200 dollars from this fund was donated throughout the community in 2018.



THE FESTIVAL The Festival Guitar fundraiser is the Volunteer Firefighter Association's biggest annual fundraiser. In 2018 the guitar actioned off for \$15,000.

The Association uses the money for community support, whether it is to purchase smoke detectors, fire prevention materials or host and equip prevention booths.

Residential Smoke Alarm Program

Our goal is to have a working smoke alarm in every home. Smoke alarms and batteries are provided at no cost to homeowners with limited financial means.

BonFire

Creating safer communities by helping individuals prevent fires and other emergencies is a priority at Selkirk Fire. We participate in the Bonner County Wildfire Protection Plan and upon request, conduct residential site evaluations, which includes: terrain features, structure construction, defensible space, water supply, address, access, and fire ignition sources.

In 2018 our Fire Marshal, Mark Sauter met with residence of Gold Hill Road and Eaglecrest. He also visited at Cliffs Above Contest Point, Wagon Bridge, Ledges, Cedar Shoals, Cheval Noir, Travelers Rest, Forest Knolls, Wrenco Loop, Red Tail, Saddle Ridge, Berg Lane, and Festive Lane.

Bonner County Food Bank Event

Firefighters, in conjunction with Super 1 Foods and Safeway raised 1,200 pounds of food and 29 turkeys.

Cancer Fund Raisers

Every year Firefighters participate in the Seattle Stair Climb for the Leukemia event and the Movember Mustache party. In 2018, \$2,406 went to Leukemia and \$1,158 went to the Bonner County Community Center and a local cancer patient.

Traffic Control Events

Volunteer Firefighters are certified and trained to provide traffic control. They provide traffic control for the Sandpoint Scenic Half Marathon and the Winter Carnival.

Fill the Boot

Firefighters raised \$2,408 for Muscular Dystrophy in 2018. This event took place at the intersection of Highway 95 and Sagle Road.

Halloween Glow Sticks

In 2018 Selkirk Firefighters and Selkirk Volunteer Association purchased and handed out 1,500 glow sticks on Halloween night.

Fire Prevention Education

Firefighters visited multiple schools throughout the month of October teaching fire safety to children in preschool through 6th grades and made contact with 1,000 to 1,250 children, including at our Open House in October. We provided public education at the Bonner County Contractors show (2 days), Schweitzer Mountain Fall Fest (2 days), and the Emergency Preparedness Fair (2 days).

Mock DUI

Firefighters provided a demonstration to the School District seniors to show the dangers of driving under the influence of alcohol and/or drugs.



World Record Run

Gwen Le Tutour . . . "That was easy!"

On April 28th Gwendal Le Tutour (one of our volunteers) ran 100 miles in full Firefighting gear in 28 hours and 43 minutes. By doing so, he set a new world record and was the first to run 100 miles in full gear. The purpose of this run was to raise awareness about cancer prevention. The Firefighter Cancer Support Network and the American Institute for Cancer Research were partners in this world record event.

This event took place in Sandpoint and organized by the non-profit Plant Positive. The Sandpoint community joined the effort by following along biking, running or skateboarding.

Firefighter Stair Climb



Gwen Le Tutour, Tennille Toussaint, and Conner Robinson were the Firefighters representing Selkirk Fire at the annual Seattle stair climb. They climbed 69 floors in full firefighting gear, on air with breathing apparatus. They raised \$2,406.00 for Leukemia and Lymphoma.
