DRAFT JOINT POWERS BOARD MINUTES

1. CALL TO ORDER AND ROLL CALL

The meeting of the Selkirk Fire Service Joint Powers Board was called to order at 2:04 p.m. by Sandpoint City Administrator Jennifer Stapleton, Board Executive Director, presiding in Council chambers at Sandpoint City Hall, 1123 W. Lake St., Sandpoint, Idaho.

Absent: Sagle Fire District Commissioner Jim Woodward, Westside Fire District Commissioner Will Gadsby (Commissioner Croft attending as alternate for Sagle Fire District and Commissioner Marx attending as alternate for Westside Fire District)

2. PLEDGE OF ALLEGIANCE

Outgoing Fire Chief Dale Hopkins led all present in the Pledge of Allegiance.

3. ANNOUNCEMENTS

Ms. Stapleton introduced:

Gavin Gilcrease, newly appointed Chief of Selkirk Fire, Rescue and EMS ("Selkirk Fire")

Tammy Miller, newly hired Administrative Assistant, providing front-line support for the City of Sandpoint customer service area at City Hall, as well as direct administrative support to the Fire Chief, Selkirk Fire Services JPA Board, and Sagle and Westside Fire Districts.

Following announcements, Ms. Stapleton requested a change in the order of the agenda, with no objections from the Board.

6. CHIEF TRANSITION PLAN AND TIMELINE

Chief Gilcrease has been provided a laptop computer and access to all of the necessary internal programs used by Selkirk Fire. As he is still transitioning from his prior employment and home to Sandpoint, he will attend the August Board meetings of the Sagle and Westside Fire District virtually. Chief Gilcrease will be in regular communication with Chief Hopkins over the next month and then "in uniform" on-site August 30. Chief Hopkins will officially retire on August 31, 2021.

4. BONNER COUNTY EMS RESPONSE

Bonner County Emergency Medical Services (EMS) Chief Jeff Lindsey provided an overview and explanation to support the Bonner County EMS position requesting an agreement to end Selkirk Fire response services for Immediate Life Support (ILS) and Basic Life Support (BLS) level emergencies. Ending these responses from Selkirk Fire will be consistent with other fire departments' services in the northern counties. Additionally, Selkirk Fire will no longer need to purchase required medical supplies for those calls, therefore allowing for more effective utilization of financial resources. Bonner County EMS requests that Selkirk Fire continue to respond to all Advanced Life Support (ALS) emergencies and to respond, when requested by Bonner County EMS, to ILS and BLS level emergencies. As discussion on this matter concluded, Ms. Stapleton clarified that, as opposed to a policy decision made by City Council and the Fire District Boards, this will be an operations decision, with the JPA Board as the governing advisory board relative to operations decision-making. She suggested a recommendation from Chief Hopkins and Chief Gilcrease as to their preference from an operations perspective, then the decision from the JPA Board would be to either dissent or concur with that recommendation. Chief Hopkins, with confirmation of agreement with Chief Gilcrease, made a recommendation that Selkirk Fire suspend response to ILS and BLS level emergencies unless assistance is requested by Bonner County EMS for the next 12 months, at which time they will evaluate the decision.

Motion for Board concurrence with the Chiefs' recommendation to suspend Selkirk Fire BLS / ILS responses unless requested by EMS for the next 12 months.
