

 This member can be an elected commissioner, administrator, volunteer or paid employee of your district.
- 3. The policy will begin February 1, 2022.
- 4. You may not add employees/volunteers until the renewal in 2023 if they come on after the deadline of January 15, 2022.
- 5. The employee/volunteer can pay for the policy if the district elects to not pay the premium. We cannot take payment from individual employees/volunteers; they must pay the district and the district pays ISFCA directly.
- 6. You may have duplicate policies with other agencies.
- 7. You may also have more than one with Provident.
- 8. Spouses cannot participate in the policy unless they are a volunteer or paid employee of the district.
- 9. If you contract with a city, those employees may participate in the plan as long as the payment comes from the fire district.
- 10. You must be a Member District of ISFCA to participate in the AD&D policy.
- 11. ISFCA facilitates the policy on the member districts behalf.
- 12. Deadline Please remit the registration form and payment no later than January 15, 2022.
